## Frequently Asked Questions

### **I'm not a VCCC Alliance Leadership Academy member. Can I nominate someone?**

Yes you can. However, by submitting a nomination, you are also opting-in to the Leadership Academy membership application. Membership is free. For more information, please visit the [Leadership Academy website](#).

### **My organisation is not part of the VCCC Alliance members/ associate members. Can I nominate someone?**

That depends on who you are nominating. The nominee has to be a cancer workforce professional or a person with lived experience involved in the cancer healthcare sector AND working in a Victorian-based organisation. The nominee does not need to be part of the VCCC Alliance member/ associate members

### **Can I submit more than one nomination?**

Yes, you can. You will need to complete the nomination form for each nomination you are making.

### **Can I submit a self-nomination?**

Yes, you can. However, you must include details of a referee that we can contact.

### **What if I can't answer all of the questions?**

We highly encourage the nominations to be completed especially the contact information and description of how the nominee/ nominated team has fulfilled the criteria. This will assist our panel in reviewing the nominations.

### **How do I know what information I need to provide for the nominations?**

You can refer to the table below to assist you in preparing to submit a nomination.
